**SINGAPORE, 27 JUNE 2013** – At 12:43am on 27 June 2013, a group of hackers known as “Indonesia J.A.M.5 Team” claimed to have breached the corporate website of Eu Yan Sang International Ltd (EYSI) at [www.euysang.com](http://www.euysang.com) and the website of Eu Yan Sang Integrative Health Pte Ltd ([www.ihealth.com.sg](http://www.ihealth.com.sg)).

Our internal IT team has since restored the websites at 8:30am today.

Richard Eu, Group CEO of EYSI said: “No client/patient data and online payments were compromised as our e-commerce data resides on a different system. This incident has no financial impact on the Group and our business is as usual. In fact, we are beefing up our online retail unit as we view this market segment as an attractive business proposition that targets the young, discerning crowd. As we speak, we are implementing much tighter security standards on all of our web properties, as well as increasing the backup frequency in order to offer a robust online experience to our customers.”
