**ISSUE AND ALLOTMENT OF SHARES PURSUANT TO EU YAN SANG EMPLOYEE
SHARE OPTION SCHEMES**

The Board of Directors of Eu Yan Sang International Ltd (the "Company") wishes to announce the issue and allotment of:

- (i) an aggregate of 102,000 ordinary shares in the capital of the Company, at the exercise price of S\$0.445 each, pursuant to the exercise of options granted under the Eu Yan Sang Employee Share Option Scheme; and
- (ii) an aggregate of (a) 114,000 ordinary shares in the capital of the Company, at the exercise price of S\$0.481 each, (b) 66,000 ordinary shares in the capital of the Company, at the exercise price of S\$0.376 each, (c) 57,000 ordinary shares in the capital of the Company, at the exercise price of S\$0.668 each, pursuant to the exercise of options granted under the Eu Yan Sang Employee Share Option Scheme 2006.

The abovementioned new shares have been listed and quoted on the Singapore Exchange Securities Trading Limited on 27 June 2013.

The new shares issued rank *pari passu* in all respects with the existing shares of the Company.

Pursuant to the above issue and allotment of new shares, the number of issued and paid-up shares in the capital of the Company is 443,945,217 ordinary shares.
